Remove the Owner/Professional Contracts (Percentage Contract, Roofing Contract, and Asbestos Contract), which appear in the Bureau of Building, Grounds and Real Property Management Procedure Manual between Section 800 and Division 0 on the Index (the professional contracts do not have a section number). Removal is being made because the Contracts are not a policy or procedure and were in the manual to simply provide an example of a contract.
