Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:

AP 2006-55. Provider Policy Manual Update to create section 43 regarding Federally Qualified Health Centers (FQHC), which includes the Introduction, Provider Enrollment/Agreement, Reimbursement Methodology, Service Limits, EPSDT, Co-Payments on Medicaid Services, Pregnancy-Related Eligibles, Documentation Requirements, Prior Authorization, Encounter/Core Services, Vision, Dental, Solid Organ/Tissue Transplant, Reserved, and Hospital Services in subsections 43.01 - 43.15 respectively. The only changes from the Proposed Rule is the cross-reference section # in section 43.15 from 43.14 to 43.10 and remove the DOM address in section 43.05. AP2006-55 Policy manual update has been withdrawn effective November 30, 2006.
