
This rule as adopted is without variance from the proposed rule.

The Mississippi Commission on Wildlife, Fisheries and Parks in a meeting in Ruleville, Mississippi on December 12, 2006, under authority of Section 25-43-7, Mississippi Code of 1972, made known its intent to, and thirty days thereafter did, adopt the following regulations on Lake Elvis Presley fees. This is done under the authority of Section 49-1-29 of the Mississippi Code of 1972 as follows :

Be it ordered that the following fees will be charged for rental cabin:

\$200 per day
\$1,000 per 7 days (week)

Reservations and overnight accommodations will be followed under Section J of Public Notice P-002.






