



Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule: The Mississippi State Board of Massage Therapy was delegated the authority to regulate and license the school of massage therapy in 2004. The purpose of this rule is to set guidelines regarding school licensure.
