Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:

Modify language of the regulation to waive the requirement to obtain foreign gaming approval for gaming within the United States, aboard cruise ships embarking from ports in the United States and for any activity outside the US that does not require a casino operator's license. This does not waive the requirement for prior approval for involvement in internet gaming.
