Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:

Modify language of regulation to comply with Miss. Code Ann. § 97-33-57(3) amended by the Mississippi Legislature 2007
General Session in House Bill 599 stating that no charitable gaming license issued under §97-33-51 through 97-33-203 shall
be effective for more than three (3) calendar years. Also amending the short title of the regulations from "Bingo" to
"Charitable Bingo Regulations."
