Specific Legal Authority authorizing the promulgation of Rule: Miss. Code Ann. § 45-4-5

Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule: The proposed rule is requiring officers working in adult facilities to complete the adult detention training program, officers working in juvenile detention facilities to complete the juvenile detention training program and officers working in both facilities to complete both training programs. The juvenile detention training program was developed to meet federal guidelines, as well as providing officers working with juveniles additional training.
