AP2007-24 This Administrative Policy amendment updates section 77.05 regarding vaccines for adults. Vaccines included
are the influenza vaccine and the pneumococcal polysaccharide vaccine; and reimbursement procedures that should be
followed by the provider. Also included is the hepatitis b vaccine, reimbursement procedures for this vaccine, dosage and
administration procedures, and the documentation required by DOM.
