Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule: Under the Administrative
Procedures Law the Secretary of State's Office issued a rule requiring Agencies to file compilations of their regulations with
the Secretary of State by July 1, 2007. Several Agencies requested that the deadline for the filing of compilations be
extended. This amendment extends the deadline to December 31, 2007, and the publication date for the Administrative Code
to July 31, 2008. This is an extension of the current rule.
