Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule: In accordance with MS State
Code §37-13-3 2) (a), the State Board of Education shall adopt and maintain a curriculum and a course of study to be used
in the public schools that is designed to prepare the state's children and youth to be productive, informed, creative citizens,
workers and leaders, and it shall regulate all matters arising in the practical administration of the school system not otherwise
provided for. The 2007 Mississippi Language Arts Framework Revised is the newly revised curriculum guide for teaching
language arts in Mississippi classrooms grades K - 12.
