Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule: The purpose of the proposed rule in Chapter 1 is to clarify acceptable accredited school districts and to lower the ACT score to 15; Chapter 5 is to add that the instructor is responsible to submit certification requests thirty (30) days prior to the date of the course and to define what costs are included as tuition costs; Chapter 7 is to require the vendor certificate to be sent to the Board.

This rule is proposed as a Final Rule, and/or a Temporary Rule (Check one or both boxers as applicable.)
