**Explanation of the purpose of the proposed rule and the reason(s) for proposing the rule:**

Amendment to regulation to allow case by case consideration of self-excluded patrons to be employed in a gaming-related position in a casino and to strike out-dated language pertaining to self-exclusion lists maintained by individual casinos separate and apart from that maintained by the Mississippi Gaming Commission.
