Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:

The amendment deletes the word, "alleged" in Section 101.05 (8) Criminal History Record Check; deletes the word "Excessive" in Section 107.01 (3) Denial, Suspension, and Revocation of a License; and adds two (2) new Sections - Section 113.01 Emergency Operations Plan (EOP) and adds a new title/section of Facility Fire Preparedness - Section 113.02 to allow placement of language from previous Disaster Planning. These two (2) new sections replace the Section formerly known as Disaster Planning.
