The Mississippi Commission on Wildlife, Fisheries and Parks, at a meeting in New Albany, Mississippi on April 2, 2008, under authority of Section 25-43-3.103, Mississippi Code of 1972, made known its intent to adopt the following wildlife management area regulations for the 2008-09 hunting year. This was done under authority of Sections 49-5-13 and 49-7-31, Mississippi Code of 1972.

**Be it ordered that Public Notice Number W10 3504 is hereby amended, and the following 2008-09 wildlife management area hunting regulations are adopted.**

**SPECIAL INSTRUCTIONS FOR NANIH WAIYA WILDLIFE MANAGEMENT AREA  
PUBLIC NOTICE OF INTENT NUMBER W11 3504(I)**

**WMA USER PERMIT:** All persons using this wildlife management area, except those exempt from purchasing an annual hunting or fishing license, must carry on their person an annual statewide Wildlife Management Area User Permit. This permit is required in addition to the daily visitor use permit and any required license.

**BAG LIMITS:** Same as statewide bag limits EXCEPT: Turkey - 2 legal gobblers per hunter.

**PERMIT STATIONS:** All visitors must obtain a DAILY VISITOR USE PERMIT card from a self-service permit station. Parts A and B of this permit must be legibly filled out before using the WMA. Part A of the permit must be deposited in the return box at a permit station before using the WMA. Part B must be kept with the visitor while on the WMA. Permits are invalid if not properly dated or if date has been changed. Before leaving the WMA, visitors must complete the reverse side of Part B of the permit and deposit it in the return box at a permit station. It is the responsibility of the Area Manager and other Agency personnel to have permit cards completed.

**LEGAL BUCKS:** Legal bucks are those with an inside spread of at least 12 inches OR one main beam length of at least 15 inches. For hunters less than 16 years of age, one of the three buck bag limit may be any antlered buck.

**DEER DATA COLLECTION:** All deer harvested must be checked at the WMA Headquarters building or at a check station by the hunter who harvested them before leaving the WMA. If WMA personnel are not available to check the deer, the hunter is responsible for collecting and legibly recording ALL biological data. Instructions and equipment will be provided.

**DOG RESTRICTIONS:** Deer hunting with dogs is prohibited. Small game hunting with dogs is allowed during any small game season. Hog hunting with dogs is allowed during daylight hours Feb. 1 - Feb. 28.

**LEGAL WEAPONS:** Only primitive weapons may be used for deer hunting. Centerfire rifles and shotguns with slugs allowed during the youth deer hunt. Legal weapons for small game hunting (excluding waterfowl) during daylight hours are shotguns using #2 shot or smaller, rifles or handguns no larger than .22 rimfire magnum, muzzleloading rifles .40 caliber or smaller, and archery equipment using arrows with points other than broadheads. Only archery equipment and shotguns with #2 shot or smaller may be used for turkey hunting. Only rimfire rifles .22 caliber or smaller or any caliber handgun with a six inch barrel or less may be used when hunting hogs with dogs.

**OFF-ROAD MOTORIZED VEHICLES/ATVs:** Off-road motorized vehicles/ATVs are allowed on designated graveled roads for hunting and fishing access only. Off-road use of ORVs/ATVs is allowed for retrieval of harvested deer or hogs. No loaded weapon may be in possession when retrieving harvested game.

**HORSES:** No horses allowed.

**CAMPING:** Campers must use a designated, primitive camp site and obtain a camping permit from the Area Manager prior to camping. Camping is limited to 14 consecutive days. Camping equipment may not be left unattended for more than 24 hours. All camping equipment and garbage must be removed before final departure.

**BEARS:** Black bears may occur on this WMA. They are federally protected as a threatened subspecies. Hunting or disturbing bears is prohibited. Please report any bear sightings on your daily visitor use permit.

**CODE OF FEDERAL REGULATIONS, TITLE 36,** will be enforced. For additional information, contact the U. S. Army Corps of Engineers at (662) 327-2142.
