**Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:**

The amendment adds to the regulations the provision that “any entity exempt from the requirements to be licensed but voluntarily chooses to obtain a license is subject to all provisions of the licensing law and these regulations.”
