Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:

Attached are the proposed Rules and Regulations of the Mississippi Wireless Communication Commission (WCC), proposed for adoption at the regularly scheduled meeting of the WCC open to the public and held on July 10, 2008. These agency rules are proposed for final adoption pursuant to the authority of Miss. Code Ann. § 25-43-2.104 and Miss. Code Ann. § 25-53-171(4). Pursuant to the authority of Miss. Code Ann. § 25-43-3.107(1) the WCC anticipates that a rule incorporating the provisions of the Mississippi Public Records Act of 1983, Miss. Code Ann. § 25-61-1, et seq., may be adopted by the WCC and included within these rules, with the exception that pursuant to Miss. Code Ann. § 25-61-5(1) the right to inspect, copy or mechanically reproduce or obtain a reproduction of a public record of the WCC shall be provided for within fourteen (14) working days after a written request for a public record is made.


This rule as adopted is without variance from the proposed rule.
