**Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:**

Gasoline-alcohol blends have a lower tolerance for water than regular gasoline. If the water content gets too high in a gas alcohol blend the product will separate. The Department adopts the National Conference on Weights and Measures recommendation of 1/4 inch tolerance of water in retail tanks for gas-alcohol blends and 1 inch water tolerance in retail tanks of gas, diesel and other fuels as set out in the attached regulation.

This notice also removes 2 unnecessary, extra commas in section 111 and changes "of" to "or."
