The Mississippi Commission on Wildlife, Fisheries and Parks, at a meeting in Jackson, Mississippi on April 21, 2009, under authority of Section 25-43-7, Mississippi Code of 1972, made known its intent to adopt the following wildlife management area regulations for the 2009-10 hunting year. This was done under authority of Sections 49-5-13 and 49-7-31, Mississippi Code of 1972.

**Be it ordered that Public Notice Number W11 3504 is hereby repealed, and the following 2009-10 wildlife management area hunting regulations are adopted.**

**SPECIAL INSTRUCTIONS FOR NANIH WAIYA WILDLIFE MANAGEMENT AREA  
PUBLIC NOTICE OF INTENT NUMBER W12 3504(I)**

**WMA USER PERMIT:** All persons using this wildlife management area, except those exempt from purchasing an annual hunting or fishing license, must carry on their person an annual statewide Wildlife Management Area User Permit. This permit is required in addition to the daily visitor use permit and any required license and may be purchased wherever licenses are sold.

**BAG LIMITS:** Same as statewide bag limits EXCEPT:  
Turkey - 2 legal gobblers per hunter.  
Rabbit - 8 per hunting party.

**PERMIT STATIONS:** All visitors must obtain a DAILY VISITOR USE PERMIT card from a self-service permit station. Parts A and B of this permit must be legibly filled out before using the WMA. Part A of the permit must be deposited in the return box at a permit station before using the WMA. Part B must be kept with the visitor while on the WMA. Permits are invalid if not properly dated or if date has been changed. Before leaving the WMA, visitors must complete the reverse side of Part B of the permit and deposit it in the return box at a permit station. It is the responsibility of the Area Manager and other Agency personnel to have permit cards completed.

**RABBIT:** Rabbit hunting will be allowed by special permit only. Selected hunters can bring 2 guests during each hunt. Each hunting party may have a maximum of 5 dogs afield. The bag limit is 8 per hunting party. You may apply online at [www.mdwfp.com](http://www.mdwfp.com) or to receive an application, send a self-addressed, stamped letter size envelope to: Nanih Waiya Rabbit Hunts, MDWFP District 4 Office, 4025 Hatchery Drive, Meridian, MS 39307. Only one application per hunter will be accepted. Applications must be received by Oct. 15, 2009. Hunters who provide an e-mail address will be notified by e-mail if drawn. Hunters who are selected and do not provide an e-mail address will be notified by mail. Rabbit hunting dates are: Dec. 2, 5, 9, 12, 16, 19, 23, 26, 30; Jan. 2, 6, 9, 13, 16, 20, 23, 27, 30; Feb. 3, 6, 10, 13, 17, 20, 24, and 27.

**LEGAL BUCKS:** Legal bucks are those with an inside spread of at least 12 inches OR one main beam length of at least 15 inches. For hunters less than 16 years of age, one of the three buck bag limit may be any buck.

**DEER DATA COLLECTION:** All deer harvested must be checked at the WMA Headquarters building or at a check station by the hunter who harvested them before leaving the WMA. If WMA personnel are not available to check the deer, the hunter is responsible for collecting and legibly recording ALL biological data. Instructions and equipment will be provided.

**DOG RESTRICTIONS:** Deer hunting with dogs is prohibited. Small game hunting with dogs is allowed during any small game season. Hog hunting with dogs is allowed during daylight hours Feb. 1 - Feb. 28.

**LEGAL WEAPONS:** Only primitive weapons may be used for deer hunting, EXCEPT that youth may use centerfire rifles and shotguns with slugs during the youth deer hunt and during primitive weapon season. Legal weapons for small game hunting (excluding waterfowl) during daylight hours are shotguns using #2 shot or smaller, rifles or handguns no larger than .22 rimfire magnum, muzzleloading rifles .40 caliber or smaller, and archery equipment using arrows with points other than broadheads. Only archery equipment and shotguns with #2 shot or smaller may be used for turkey hunting. Only rimfire rifles .22 caliber or smaller or any caliber handgun with a six inch barrel or less may be used when hunting hogs with dogs.

**OFF-ROAD MOTORIZED VEHICLES/ATVs:** Off-road motorized vehicles/ATVs are allowed on designated graveled roads for hunting and fishing access only. Off-road use of ORVs/ATVs is allowed for retrieval of harvested deer or hogs. No loaded weapon may be in possession when retrieving harvested game.

**HORSES:** No horses allowed.

**CAMPING:** A WMA Camping Permit is required for any individual or group (maximum of 6 people) that is camping on this WMA and may be purchased wherever licenses are sold. Campers must also use a designated, primitive camp site and obtain a camping permit from the Area Manager prior to camping. Camping is limited to 14 consecutive days. Camping equipment may not be left unattended for more than 24 hours. All camping equipment and garbage must be removed before final departure.

**BEARS:** Black bears may occur on this WMA. They are federally protected as a threatened subspecies. Hunting or disturbing bears is prohibited. Please report any bear sightings on your daily visitor use permit.


