Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:

AP2009-56 This administrative policy amendment issues revised policy for the Medicaid Eligibility Policy and Procedures Manual. In September 2008, staff was informed this generic manual would be compiled over time by adding additional sections as policy is re-issued or revised. The material on special reviews, notification and reinstatements completes Chapter 101, Application and Redetermination Processes. A revision of page 621 provides a clarification regarding QMB eligibility. In addition, we will begin building Chapter 300, Resources, starting with "Exceptions to Treatment of Trusts" which includes a discussion of Special Needs Trusts, Pooled Trusts, Income Trusts, Model Income Trust Documents, and Revised Life Expectancy Tables.


