The Mississippi Commission on Wildlife, Fisheries and Parks, at a meeting in Jackson, Mississippi on May 19, 2010, under authority of Section 25-43-7, Mississippi Code of 1972, adopted the following wildlife management area regulations for the 2010-11 hunting year. This was done under authority of Sections 49-5-13 and 49-7-31, Mississippi Code of 1972.

Be it ordered that Public Notice Number W14 3449 is hereby repealed, and the following 2010-11 wildlife management area hunting regulations are adopted.




