Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal:  
The 2010 Legislature amended the administrative penalty of the Petroleum Products Inspection Law by removing the \$1,000.00 minimum penalty and provided certain administrative procedures. Accordingly, the Department is proposing this amendment to its General Rules of Procedures wherein the current rules of procedure are amended to reflect the changes in the law. The proposal sets penalties for specific violations of the Law and provides an appeal procedure.






At any time within the twenty-five (25) day public comment period, written submissions including arguments, data, and views on the proposed rule/amendment/pepeal may be submitted to the filing agency.
