Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: : This proposed rule will amend the present regulations by postponing the effective date of the rule for Organic Emission Standards for Tanks, Surface Impoundments, and Containers. incorporating by reference federal regulations promulgated that implement changes to regarding transboundary movement of spent lead-acid batteries, that make technical changes that correct or clarify several parts of the hazardous waste regulations as well as correct existing errors in the hazardous waste regulations that have occurred over time in numerous final rules such as typographical errors, incorrect or outdated citations, and omissions, that withdraw four amendments made in the March 18, 2010 regulations, and correct several errors and omissions such as typographical errors, number transpositions, and incorrect citations.
