Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule: Revisions of the FY 2011 Mississippi State Health Plan to update statistical data for health care facilities and services and other information concerning health care issues. Further this includes changes to Chapter 5, Acute Care changes to criterion for projects which involve the addition of beds at acute care hospitals; Chapter 5, Diagnostic Imaging Services, Positron Emission Tomography (PET) Equipment and Services (to provide for Cardiac only PET Scanners); and Chapter 7, Other Health Services, revision of End Stage Renal Disease Services.
