The proposed amendment to Regulation 14 is to emphasize the due date for filing of the Annual Financial Report required of each covered constable, chancery clerk, and circuit clerk, as well as, for the payment of all retirement contributions for each calendar year in office. The amendment also reflects the manner in which interest is calculated and assessed for contribution amounts not paid when due.



