Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The proposed regulations: "Recycling Cooperative Grant Regulations" (No. SW-10), addresses the establishment and administration of the Recycling Cooperative Grants Fund. This fund will be used to provide grants to regional recycling cooperative organizations for the purpose of collection, processing and marketing of recyclables. The proposed regulations will include requirements related to the eligibility and allocation of funds, the required grant application procedures and content, and the conditions of grant awards.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. 49-2-9(1)(b) Rev. 2003 and 17-17-63(3)(d)


