Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The purpose of the proposed amendments to Tariff No. 6 is to clarify the currently effective and applicable provisions of Tariff No. 6, add a Terminal Safety Regulation Section, add language related to the stevedore license requirement and increase the tariff rates for certain services provided at the State Port at Gulfport to cover the increased cost of providing marine terminal services at the State Port.
