Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The proposed amendment to Regulation 30 reflects the change in the retirement formula made by S.B. 2439 of the 2011 Legislative Session, which provides that there will be no minimum monthly retirement allowance for any member of the Public Employees' Retirement System of MS who becomes a member on or after July 1, 2011.
