Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The purpose of the proposed amendments to Commission Regulation WPC-2 is to update the Mississippi Water Quality Criteria for Intrastate, Interstate, and Coastal Waters. The proposed modifications include: revising human health criteria to be consistent with EPA recommendations; establishing site-specific dissolved oxygen criteria for the Escatawpa River, reviewing/revising surface water use classifications, revising language within the temperature standard for improved clarity, and adding an Antidegradation Implementation Policy to regulations. This proposed amendment will update and re-issue the previous version of WPC-2.


