Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: To bring Regulations of Pearl River Valley Water Supply District (the "District") in compliance with Rule 3.2 of the Administrative Procedures Act Rules, Revised 2010. The District adopts the 2006 International Building Code®, the 2006 International Residential Building Code®, the 2006 International Plumbing Code®, the 2006 International Mechanical Code® and the 2008 NFPA 70 National Electric Code® (the "Codes") as regulations of the District, as amended by Rule 1.1 of Title 33, Part 205. A copy of the Codes shall be maintained at all times in the office of the District's Building Inspector.
