NOTICE OF PUBLIC HEARING
PUBLIC NOTICE START DATE: NOVEMBER 4, 2011

PLEASE TAKE NOTE that the Mississippi Commission on Environmental Quality (“Commission”) is considering a proposed Revision to the State Implementation Plan for Air Pollution Control (SIP Revision) and proposed amendments to state air pollution control regulations. The proposed SIP Revision and proposed regulation amendments will be applicable statewide.

I. Substance of the proposed actions:

1. The proposed amendments to “Air Emission Regulations for the Prevention, Abatement, and Control of Air Contaminants,” APC-S-1 involve the adoption, by reference, of amendments to Federal New Source Performance Standards, as promulgated in 40 CFR Part 60 and Federal National Emission Standards for Hazardous Air Pollutants as promulgated in 40 CFR Parts 61 and 63.
2. The proposed SIP Revision and proposed amendments to “Regulations for the Prevention of Significant Deterioration of Air Quality”, APC-S-5 involves adoption, by reference, of amendments to federal regulations as promulgated in 40 CFR Parts 51.166 and 52.21 in order to make the state Prevention of Significant Deterioration of Air Quality (PSD) permitting program consistent with federal requirements.
3. The proposed amendments to “Air Emissions Operating Permit Regulations for the Purposes of Title V of the Federal Clean Air Act”, APC-S-6 involve amendments to make the Title V permitting program consistent with federal requirements.
4. The proposed amendments to “Acid Rain Program Permit Regulations for the Purposes of Title IV of the Federal Clean Air Act”, APC-S-7 involve adoption , by reference, amendments to Federal Acid Rain Permit Program regulations as promulgated in 40 CFR Parts 72 and 76.
