This was done under authority of Sections 49-1-29 and 49-5-13, Mississippi Code of 1972.

**Be it ordered that Public Notice W 3814 is hereby repealed, and the following regulations are adopted.**

Be it ordered that that following fees will be charged for rental of the facilities at Black Prairie WMA, Charles Ray Nix WMA, or Hell Creek WMA:

\$150.00 for one day and \$50 for each additional day.



No alcoholic beverages area allowed on WMA property.


