The Mississippi Commission on Wildlife, Fisheries and Parks, at a meeting in Jackson, Mississippi on April 18, 2012, under authority of Section 25-43-3.103, Mississippi Code of 1972, made known its intent to adopt the following wildlife management area regulations. This was done under authority of Sections 49-5-13, Mississippi Code of 1972.

Be it ordered that Public Notice Number W4 3789 is hereby repealed, and the following wildlife management area hunting regulations are adopted.

NO OTHER SEASON shall be open and no other animals shall be hunted or disturbed.

SPECIAL INSTRUCTIONS

WMA USER PERMIT: All persons using this wildlife management area, except those exempt from purchasing an annual hunting or fishing license, must carry on their person an annual statewide Wildlife Management Area User Permit. This permit is required in addition to the daily visitor use permit and any required license and may be purchased wherever licenses are sold.

BAG LIMITS: Same as statewide.

PERMIT STATIONS: All visitors must obtain a DAILY VISITOR USE PERMIT card from the self-service permit station. Parts A and B of this permit must be legibly filled out before using the WMA. Part A of the permit must be deposited in the return box at the permit station before using the WMA. Part B must be kept on the dash of the vehicle while on the WMA. Permits are invalid if not properly dated or if date has been changed. Before leaving the WMA, visitors must complete the reverse side of Part B of the permit by recording the number of animals harvested and deposit it in the return box at the permit station. It is the responsibility of the Area Manager and other Agency personnel to have permit cards completed.

DEER DATA COLLECTION: All deer harvested must be recorded on the DAILY VISITOR USE PERMIT card.

LEGAL DEER: Antlerless deer and bucks with hardened antlers visible above the natural hairline are legal for harvest.

WILD HOGS: Wild hogs are classified as nuisance animals and hunters are encouraged to kill them at every lawful opportunity. The opportunity to kill hogs on WMAs is provided only for population control purposes and not for sport. Wild hogs may be killed during daylight hours only during any open WMA hunting season with weapons and ammunition legal for that season. Trapping (including snaring) of hogs is prohibited. Moving or transporting live hogs is prohibited.

DOG RESTRICTIONS: Deer hunting with dogs is prohibited. Small game hunting with dogs is allowed during any small game season. Hunting, running, or pursuing hogs with the use of dogs is prohibited.

LEGAL WEAPONS: Only centerfire rifles, shotguns with slugs or buckshot, primitive weapons, and centerfire handguns may be used for deer hunting.

OFF-ROAD MOTORIZED VEHICLES/ATVs: ORVs/ATVs are allowed on designated trails and for the retrieval of harvested deer or hogs only.


HORSES: No horses allowed.

CAMPING: No camping allowed.


