Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The Mississippi 2012 Section 303(d) List of Impaired Water Bodies identifies those waters within the state for which recent monitoring and assessment have found pollutant specific impairment and for which Total Maximum Daily Loads (TMDLs) are not yet completed. It updates and replaces the previous version of this List.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. §§ 49-2-9(1), 49-17-17, 49-17-19, and 49-17-25 (Rev. 2003)

List all rules repealed, amended, or suspended by the proposed rule: Replaces and supersedes the previous version, which is entitled "Mississippi 2010 Section 303(d) List of Impaired Water Bodies".
