Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Rule is amended to allow alcoholic beverage products to be used as samples to be purchased from a package retailer as well as from the ABC's liquor distribution center. Also amended to require written approval from a manufacturer to withdraw products for sample use, with such written approval including a description of the product and the amount, and subjects withdrawal of product for samples to limitation by the ABC Director.
