Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: **New Rule:** (Part 2 Ch. 11) MDAH maintains a list of standards required for the reproduction of public records when using digital imaging and microfilming systems. By setting these standards, MDAH seeks to ensure that public records maintained only in microform or digital image formats will remain accessible to the public or custodian for the full period that the records must be retained. **Amended:** (Part 2 Ch. 6) Update of materials allowed in the reading rooms and duplication request mailing expense.




