Regulation 49: Conditions for Existing Military Service at No Cost and Qualified Military Service Due to Interruption of Employment Available Upon Payment of Required Employer and Employee Contributions

1. Amend § 102.3.b to remove the mailing address for the National Personnel Records Center so that the regulation does not have to be amended whenever the address changes; and
2. Make other stylistic changes to conform to established formatting standards. The effective date of the proposed amendment will be April 1, 2014.
