Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal:

The proposed amendments to Regulation 59 are to incorporate the actuarial assumptions for service and disability retirees for PERS, SLRP, and MHSPRS as adopted by the PERS Board June 18, 2013, in conjunction with the Experience Investigation, which showed improved mortality for retirees over the four-year period that ended June 30, 2012. The effective date of the proposed amendments will be July 1, 2014.
