Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: Rule is amended to clarify the Department's position that recycling, scrap metal processing and other preparatory functions are not "manufacturing" activities subject to the 1.5% tax rate on the sale of manufacturing machinery and machine parts.
