This Rule is a result of HB 487 Approved by the Governor 3/1/14 with an effective date of 1/1/2015. The House Bill creates a Uniform State Tax Lien Registry for the filing of Tax Liens. The Registry is maintained by the Mississippi Department of Revenue.



At any time within the twenty-five (25) day public comment period, written submissions including arguments, data, and views on the proposed rule/amendment/repeal may be submitted to the filing agency.


