Short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: Revisions to existing rules- Separated rules for applications for examination from rules for registration by examination, clarified provisions for the intern development program, revised rules for emeritus status to pertain to retirement from practice in Mississippi and general housekeeping revisions. New rules adopted to clarify that architects are not exempted from practice requirements or standard of care due to project size or type, and to include expert testimony provisions within the code of conduct.
