Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The proposed repealed regulation addresses the Teachers' Retirement System (TRS), which was closed to new members when the Public Employees' Retirement System (PERS) was established. Teachers and school administrative personnel became active members of PERS. The last recipient under the TRS legacy plan died in June 2007. The effective date of the repealed regulation will be August 1, 2016.
