Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: To amend the rule governing joint ventures to clarify that when a joint venture is formed, either the joint venture itself must possess a certificate of responsibility with the required classification necessary for performing the work or each member of the joint venture must possess a certificate of responsibility with each member also possessing the required classification necessary to perform the work.
