






MINUTES OF THE BELZONI MUNICIPAL DEMOCRATIC ELECTION  
COMMITTEE  
THURSDAY, JUNE 6, 2013


The Belzoni Municipal Democratic Election Committee met on Thursday, June 6, 2013, at 9:00 a.m. at City Hall in Belzoni, MS. Larry Solomon, Chairman, Fred Avery, Mable Pierce, and Carol Ivy were present. Joyce McNair was absent. Samuel Johnson vs Gary Farmer petition to contest election by Attorney Willie Perkins, Sr., Mr. Johnson's attorney, stated 2 affidavits were counted that were illegal and unlawful votes. Witness Deloris Harris, City Clerk, was sworn in by Tamika Jones, Circuit Clerk of Humphreys County. The seal # 070548 on Ward 5 ballot box was removed. It was brought to our attention that both affidavit voters were not listed in the S.E.M.S. book (State Election Management System).

Two affidavit ballots were originally counted for Gary Farmer; however, after reviewing the S.E.M.S. book, these were found to be registered outside the City of Belzoni city limits.


Motion was made by Fred Avery and seconded to disqualify these two affidavit ballots as the voters were not registered in the city. The motion carried with a 3 to 1 vote.

Motion was made by Fred Avery and seconded to declare Samuel Johnson Alderman for Ward 5 with 88 votes to Gary Farmer's 87 votes. The motion carried unanimously.
