
Mr. Hosemann:

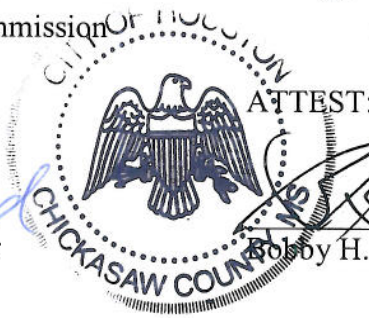
