

Thank you and your staff for all of your assistance during the City elections.

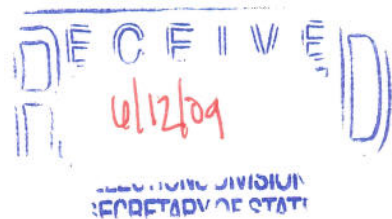
