A short explanation of rule/amendment/pepeal and reason(s) for proposing rule/amendment/pepeal: This rule is amended to reflect the internal policy changes regarding changes to the violations and fees table found in Chapter 28. Additionally, the amendments, to reflect changes to the code from SB 2857, set certain application procedures and provide the requisite considerations for who may be considered an agent and officer of a medical cannabis establishment. The changes also delete the weekly limit on the allowable amount of medical cannabis that a resident cardholder may obtain. Also, to align with HB 1158 (2023) the amendment includes language regarding the sale of "topical cannabis products," and various administrative appeals and procedure changes

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-65-93, "(1) The commissioner shall, from time to time, promulgate rules and regulations, not inconsistent with the provisions of the sales tax law, for making returns and for the ascertainment, assessment, and collection of the tax imposed by the sales tax law as he may deem necessary to enforce its provisions. In addition, more legal authority can be found at Miss. Code Ann. Sections 41-137-41, 25-43-1.103, and 25-53-1
