Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The amendment consists of removing a reference to the Interstate Commerce Commission (I.C.C.) and replacing it with a reference to the Mississippi Public Service Commission. This paragraph reflects that the I.C.C. has been disbanded on the federal level since 1995 and the Mississippi Public Service Commission is the state-level agency that may set the rates considered in 27-65-17(g). The document that amends this regulation also contains a table of contents, this table is included to update numbering and formatting for all of Part IV.

Specific legal authority authorizing the promulgation of rule: Miss. Code Ann. Section 27-65-93, "(1) The commissioner shall, from time to time, promulgate rules and regulations, not inconsistent with the provisions of the sales tax law, for making returns and for the ascertainment, assessment, and collection of the tax imposed by the sales tax law as he may deem necessary to enforce its provisions
