

Dear Mr. Hosemann:

I hand you herewith the following:

- 1. Cashier's check for \$500.00 filing fee payable to Mississippi Secretary of State as provided in Miss. Code Ann. §23-17-21.
- 2. Petition(s) with 119,251 signatures, properly certified by the Circuit Clerk of each county in which the petition was circulated. There are more than the statutorily required number of signatures from each of the five congressional districts as they were constituted in the year 2000.

This filing and fee comply with the requirements of said §23-17-21, and it is filed more than 90 days before the next session of the Mississippi Legislature and well in advance of one year after November 24, 2009, the date I received from you the ballot title and summary. I request that you will file it with the 2011 session of the Mississippi Legislature as required by Miss. Code Ann. §23-17-29 as it fully complies with the requirements of Miss. Code Ann. 23-17-1 et seq. and Mississippi Constitution of 1890, Art. 15 §273.

As requested in the Assistant Secretary of State for Elections letter to me of September 24, 2010, I have divided the documents requested as follows:

- 1. This cover letter and a copy thereof with Exhibit "A" thereto, a summary of the number of signatures collected, organized by congressional districts and then by county. Please mark the copy "received" with the date of receipt and return it to me.
- All executed original petition forms with original certification forms by the proper Circuit Clerks. These are organized first by former congressional district, then by counties within each district.
- 3. A copy of each original certification form bound separately from the originals organized first by former congressional districts then by counties within each district.
- 4. Since the signatures exceed by 30,006 the necessary number to get the petition on the ballot, there is nothing further needed to explain or support the petition.
