MUNICIPALITIES

Mississippi law classifies municipal corporations, commonly referred to as municipalities, according to population size. Municipalities with populations of 2,000 inhabitants or more are classified as cities and those municipalities having less than 2,000 and not less than 300 inhabitants are classed as towns. Municipalities with less than 300 inhabitants and not less than 100 inhabitants are considered villages. While there is no existing authority which permits the creation of a new village, the State continues to recognize existing villages. The classification of municipalities is dictated by the results of each decennial U.S. Census.

Mississippi's most recent municipality is the city of Gluckstadt in Madison County. It was incorporated on May 28, 2021. Natchez is the State's oldest municipality and was incorporated on March 10, 1803.

Unincorporated areas may incorporate to become a municipality by filing a petition signed by two-thirds of the qualified voters who reside in the proposed municipality in the chancery court of the county in which the area is located. The petition must describe the boundaries of the municipality, designate a corporate name, identify the number of inhabitants, calculate the assessed value of real property within the area according to the latest assessments, state the reasons for incorporation, identify the services to be offered, and provide a list of interim municipal officials. If the chancery court grants the incorporation, a decree is entered and such decree, if not appealed, becomes effective 10 days after it is entered.

The major function of municipal government is to provide services for its citizens such as maintaining roads and bridges, providing law enforcement and fire protection, and furnishing health and sanitation services.

In Mississippi, state law establishes different types of municipal governments, as described in Miss. Code Ann. Title 21 et seq. (1972). In current practice, municipalities in the state are operating under one of the forms of municipal government listed below.

Private Charter form – Municipalities operating under a private charter (also referred to as a special charter) were formed prior to the Mississippi Constitution of 1890 and have elected to retain their private charter. The source of the municipality's power to act is generated from the private charter.

Code Charter form – The code charter form of government is commonly referred to as the mayor-aldermen form (also known as the weak mayor form) and has been adopted by approximately 95% of the municipalities in the state. Voters elect a mayor and a board of aldermen, which varies from three, five, or seven members depending on the population of the municipality. The mayor holds supervisory authority over the municipal officers and municipal affairs and is charged with enforcing the municipal laws and ordinances. The mayor must be a qualified elector of the municipality and is elected at-large. The board of aldermen holds the power to make motions and votes on municipal ordinances, orders, and resolutions. Members of the board of aldermen must be qualified electors and are elected at large, by ward, or a combination of ward and at-large.

Mayor-Council form – The mayor-council form of government is commonly referred to as the strong mayor form. Voters elect a mayor and a city council, which is comprised of five, seven, or nine members. The mayor has the power to hire and fire municipal employees and is charged with enforcing the municipal laws and ordinances. The mayor must be a qualified elector of the municipality and is elected at-large. The city council exercises legislative functions in the municipality and its members are elected either by ward or by some combination of ward or at-large voting.

Council-Manager form – The council-manager form of government does not provide a separation of executive and legislative powers between a mayor and the city council. Voters elect the members of the city council, which consists of a mayor and five councilmen. The city council exercises the legislative power of the municipality and hires a city manager, who is the chief administrative officer of the municipality. While the council is the policy-making body for the municipality, the city manager handles the day-to-day operations, including the hiring/firing of city employees, budget preparation, and fiscal management. The mayor and councilmen must be qualified electors of the municipality. The mayor is elected at-large and councilmen are elected at-large or one councilman at-large and the others by ward.

Commission form – The commission form combines the executive and legislative powers of the municipality. Voters elect a mayor and at least two commissioners. The mayor and each commissioner must be a qualified elector and a bona fide resident of the municipality for at least one year. By statute, the commissioners are to be elected at-large, but in practice in municipalities operating under the commission form, the mayor is elected at-large and commissioners are elected by ward. The commission acts as one body and is authorized to perform all the corporate powers, duties, and obligations of the municipality.

Council form – The council form of government combines the executive and legislative powers of the municipality. Voters elect a mayor and six members of the council. The mayor and councilmen must be qualified electors of the municipality. The mayor is elected at-large and the remaining councilmen are elected from each ward into which the municipality is divided. If there are less than six wards, the remaining councilmen are elected at-large. Only one municipality in this state meets the population requirements for adoption of the council form of government.
