

## RESOLUTION

Whereas, it is necessary for the Occupational Licensing Review Commission to issue a resolution regarding the approval or denial of specific rules submitted for its review: NOW, THEREFORE, LET IT BE RESOLVED BY THE OCCUPATIONAL LICENSING REVIEW COMMISSION, that the following rules shall be known to have been approved by the Commission at a duly-called meeting of its members on June 10, 2024, and may now be filed as final with the Secretary of State's Office for inclusion in the Mississippi Administrative Code:

- <u>Mississippi State Board of Public Accountancy</u> Title 30, Part 1, Forward and Chapter 1, Rule 1.1: Restrictions on use of Title Certified Public Accountant. Removal of repetitive language and revision of existing regulations to make consistent with statute.
- <u>Mississippi State Board of Public Accountancy</u> Title 30, Part 1, Chapter 3, Rules 3.1.4, 3.1.5, and 3.1.11: Firm Permits. Removal of inaccurate and unnecessary language, shorten rule by reference to statute; and proposal for replacement of antiquated language.
- <u>Mississippi State Board of Public Accountancy</u> Title 30, Part 1, Chapter 4, Rules 4.1.1, 4.1.2, 4.1.3, 4.1.4, 4.1.5, 4.2.1, and 4.3.6: Continuing Professional Education and Repeals Rules 4.1.8 and 4.2.5. Revised language to include required CPE hours the year following licensure. Removal of antiquated and duplicative language.
- <u>Mississippi State Board of Public Accountancy</u> Title 30, Part 1, Chapter 5, Rules 5.2, 5.3.1, 5.3.3, 5.3.4, 5.3.7, 5.6, 5.7, and 5.8: Quality Review/Peer Review Rules. Revision to change "Quality Review" to "Compliance Assurance Program." Also removes antiquated language from the rules.
- <u>Mississippi State Board of Public Accountancy</u> Title 30, Part 1, Chapter 8, Rules 8.2.1 and 8.2.3: State Board of Public Accountancy Repeal of 8.1.1, 8.2.4, and 8.2.14. Repeals language that is found in Miss. Code Ann. § 73-33-3.
- <u>Mississippi Board on Law Enforcement Officer Standards and Training</u> Title 31, Part 301, Chapter 1, Rule 1.1: Definitions and Chapter 2, Rule 2.2: Policy. Revision of existing regulation to amend the policy concerning military discharge in other than honorable conditions.
- <u>Mississippi Board of Pharmacy</u> Title 30, Part 3001, Article XXX:
  Institutional/Long Term Care Facilities. Revision of an existing rule regarding requirement for dispensing medication in a long-term care facility. Revision of

language to replace the word "institutional" with "facility."

- <u>Mississippi Board of Pharmacy</u>— Title 30, Part 3001, Article XXXV: Institutional Emergency Medication Kit Permits. Revision of an existing rule regarding regulations for the permitting of an institutional emergency medication kit for a long-term care facility and other institutional facilities.
- <u>Mississippi Board of Pharmacy</u>— Title 30, Part 3002: Various Administrative Rules. Amendment to existing regulations to update numbering throughout and adding/updating language in Rules 1.1, 3.2, 4.6, 5.1, 6.1, 6.2, 6.3, 6.4, 6.6, 6.7, 6.8, and 6.9. The proposed amendments in Chapter 8 were not approved.
